The prerogative of the Grand Master to preside over every assembly of the craft, wheresoever and whensoever held.</p> <p>6. The prerogative of the Grand Master to grant dispensations for conferring degrees at irregular times.</p> <p>7. The prerogative of the Grand Master to grant dispensation for opening and holding lodges.</p> <p>8. The prerogative of the Grand Master to make Masons on sight.</p> <p>9. The necessity of Masons to congregate in lodges.</p> <p>10. The government of every lodge by a Master and two Wardens.</p> <p>11. The necessity that every lodge, when duly congregated, should be tyled.</p> <p>12. The right of every Mason to be represented in all general meetings of the craft and to instruct his representatives.</p> <p>13. The right of every Mason to appeal from the decision of his brethren in lodge convened, to the Grand Lodge or General Assembly of Masons.</p>	<p>1. Modurile de recunoastere.</p> <p>2. Marele Maestru are privilegiul de a conduce toate adunarile a ordinului, oriunde si oricand ar avea loc acestea.</p> <p>6. Marele Maestru are puterea de a acorda dispense pentru conferirea de grade in momente iregulare (in afara ritualului).</p> <p>7. Marele Maestru are puterea de a acorda dispensa pentru infiintarea si functionarea de noi loji.</p> <p>8. Marele Maestru se bucura de prerogativul de a consacra masoni "la vedere" sau "sub sabie".</p> <p>9. Necesitatea Francmasonilor de a se reuni in Loji.</p> <p>10. Fiecare loja este condusa de catre un Maestru Venerabil si doi Supraveghetori.</p> <p>11. Cand se reuneste, fiecare loja are obligatia de a lucra acoperit.</p> <p>12. Fiecare Mason are dreptul de a fi reprezentat in toate Adunarile Generale ale Ordinului si de a instrui reprezentantii sai cu privire la mandatul incredintat.</p> <p>13. Fiecare Mason are dreptul de a face apel la Marea Loja sau Adunarea Generala a Masonilor fata de o decizie luata de Loja sa.</p>

<p>14. The right of every Mason to visit and sit in every regular lodge.</p> <p>15. That no visitor, not known to some brother present as a Mason, can enter a lodge without undergoing an examination.</p> <p>16. That no lodge can interfere in the business or labor of another lodge.</p> <p>17. That every Freemason is amendable to the laws and regulations of the Masonic Jurisdiction in which he resides.</p> <p>18. That every candidate for initiation must be a man, free born and of lawful age.</p> <p>19. That every Mason must believe in the existence of God as the Grand Architect of the Universe.</p> <p>20. That every Mason must believe in a resurrection to a future life.</p> <p>21. That a book of the law of God must constitute an indispensable part of the furniture of every lodge.</p> <p>22. That all men, in the sight of God, are equal and meet in the lodge on one common level.</p> <p>23. That Freemasonry is a secret society in possession of secrets that cannot be divulged.</p> <p>24. That Freemasonry consists of a speculative science founded on an operative art.</p> <p>25. That the landmarks of Masonry can never be changed. These constitute the landmarks, or as they have sometimes been called, "the body of Masonry," in which it is not in the power of man or a body of men to make the least innovation.</p>	<p>14. Cartea legii lui Dumnezeu trebuie sa fie prezenta in fiecare loja.</p> <p>22. Toti oamenii sunt egali in ochii lui Dumnezeu si cand se intalnesc in loja sunt la acelasi nivel.</p> <p>23. Ordinul Francmasonic este o societate secreta detinatoare a unor secrete care nu pot fi divulgata.</p> <p>24. Francmasoneria este o stiinta speculativa intemeiata pe o arta operativa.</p> <p>25. Reperele (Landmark-urile) Masoneriei nu pot fi schimbat. Acestea sunt reperele, cunoscute si sub numele de "corful Masoneriei", si nu sta in puterea niciunui om sau grup de oameni sa faca nici cea mai mica inovatie.</p>
